Dispatched to: 1st Alarm assignment to a reported structure fire, fully involved at 1502 Johnson with victims trapped inside.

Conditions found: Upon arrival, T-1 found a well involved two story residential building with flames and smoke seen from both floors on sides A, B, D, as well as the attic vents. The occupants reported that all residents were out of the building and accounted for, and were under the care of SLAS personnel shortly after arrival, six occupants were treated at French hospital for smoke inhalation.

Actions taken: BC 2 Took command of the incident and called a 2nd alarm, SLOFD Engine 2 assisted with water supply and performed fire attack on Side A. Engine 3 performed interior fire attack on side B, Cal-Fire Engines 12 & 21 assisted in fire attack operations, E-4 was assigned RIC and accountability, and T-1 performed ventilation (vertical ventilation on side B/C corner of 2nd floor), lighting the scene, laddered the building, and utilities.

Offensive operations continued until IC declared the structure too hazardous to continue interior fire attack, and defensive operations commenced utilizing the aerial master stream and exterior hose lines. Upon knockdown, all personnel performed salvage of occupants property and overhaul. The building was turned over to the owner and serve pro.

Follow up: The Red Cross responded to the scene and provided the displaced occupants shelter and aid. Fire Investigators Madden, Brown, and D. Parker arrived on scene and conducted an investigation (see supplemental).

Possible cause: See fire investigation supplemental report.

Notifications-Building Department was notified and on scene, Press release was issued.

Conditions found: Upon arrival E3 found a two story residential structure with heavy smoke and fire showing from multiple windows on both floors of side A and door on side B. BC2 arrived at scn along with E3 and assumed command as Johnson IC. All occupants reported out of the structure.

Actions taken: E3 and crew performed walk-around, obtained water supply and prepared for interior fire attack from side B while E2 performed fire attack on side A. Once RIC was in place E3 made entry into first floor of side B and knocked down fire on side B and corner A/B. After fire on first floor was knocked down E3 crew proceeded to 2nd floor. E3 pulled ceiling in multiple locations looking for fire in the attic. Heavy fire activity found in attic space on side D of the second floor. E3 relieved by E2 crew when air supply ran low. E2 advised of overhead fire and E3 crew proceeded outside. E3 made contact with IC to give report on conditions, evacuation of the building then ordered and defensive operations begun and aerial master stream put into service. E3 assigned to overhaul and salvage.

Follow up: E3 avail. at scn. Scene left in care of Truck 1 crew.

Structure Fire

San Luis Obispo – A structure fire in a home located at 1502 Johnson Ave. was reported at approximately 3:38 AM. The reports stated that people were inside. Upon arrival fire engines were confronted with a two story house well involved in fire. Firefighters immediately began an aggressive interior attack and a searched for victims. A total of nine people, all approximately in their 20s, were staying at the home and self evacuated. One young woman jumped out of a second story window onto a porch cover and then to the ground. Five of the occupants were transported to a local hospital mostly with smoke inhalation. The fire required a second alarm to extinguish. Because of the extensive fire involvement in the hidden attic spaces, the truck company was used for aerial operations. Units from County/CAL FIRE assisted. A total of 5 fire engines, 1 truck company, an air support unit and chief officers were needed. The structure fire is still under investigation.
